HUBUNGAN ANTARA MOTIVASI DENGAN KEPATUHAN PERAWAT DALAM PENGGUNAAN ALAT PELINDUNG DIRI (APD) DI INSTALASI RAWAT INAP RUMAH SAKIT UMUM DAERAH PANDAN ARANG BOYOLALI

Latar Belakang: Penularan penyakit dapat beresiko pada semua petugas kesehatan apabila selama melakukan tindakan pada pasien tidak memperhatikan tindakan pencegahan yaitu menggunakan alat pelindung diri (APD). Kepatuhan perawat dalam penggunaan alat pelindung diri sangat berpengaruh pada penularan penyakit. Faktor motivasi dapat meningkatkan kepatuhan individu dalam penggunaan alat pelindung diri (APD).

Tujuan: Mengetahui hubungan antara motivasi dengan kepatuhan perawat dalam penggunaan alat pelindung diri (APD) di Instalasi Rawat Inap RSUD Pandan Arang Boyolali.

Metode: Penelitian ini merupakan penelitian kuantitatif dengan rancangan deskriptif korelasional. Populasi penelitian adalah seluruh perawat yang bekerja di Instalasi Rawat Inap RSUD Pandan Arang Boyolali yang berjumlah 156 perawat. Sampel diambil sebanyak 61 perawat dengan rumus Slovin, sedangkan teknik sampling menggunakan *proportional stratified random sampling*. Teknik pengumpulan data dengan kuesioner motivasi dan kepatuhan penggunaan alat pelindung diri. Teknik Analisis yang digunakan dengan Uji *Chi Square*.

Hasil: (1) Motivasi perawat yang termasuk kategori tinggi berjumlah 40 perawat (65,6%) dan yang termasuk kategori cukup sebanyak 21 perawat (34,4%). (2) Kepatuhan dalam penggunaan alat pelindung diri mayoritas yang termasuk kategori patuh berjumlah 46 perawat (75,4%) dan kategori cukup sebanyak 15 perawat (24,6%). (3) Ada hubungan antara motivasi dengan kepatuhan perawat dalam penggunaan alat pelindung diri (APD) di Instalasi Rawat Inap RSUD Pandan Arang Boyolali.

Simpulan: Adanya hubungan antara motivasi dengan kepatuhan perawat dalam penggunaan alat pelindung diri (APD).

ABSTRACT

THE CORRELATIONS BETWEEN MOTIVATIONS WITH NURSING COMPLIANCE IN USE OF PERSONAL PROTECTOR EQUIPMENT (PPE) IN INSTALLATION IN PATIENT PANDAN ARANG HOSPITAL OF BOYOLALI

Background: *The disease transmission can happen to all health workers if during the action at the patient does not pay attention to preventive measures was to use personal protective equipment (PPE). Enforcement for nurses against the use of protective equipment are very influential on the transmission of diseases. Factor of motivation can improve adherence to the individual in the use of personal protective equipment (PPE).*

Objective: *Knowing the relationship between motivation and nurse compliance in the use of personal protective equipment (PPE) at Inpatient Installation RSUD Pandan Arang Boyolali.*

Method: *This research is a quantitative research with correlational descriptive design. The research population is all nurses who work in Installation of Inpatient RSUD Pandan Arang Boyolali which amounted to 156 nurses. The sample was taken as many as 61 nurses with Slovin formula, while the sampling technique using proportional stratified random sampling. The collection data techniques with motivational questionnaires and compliance with the use of personal protective equipment. Analysis technique used with Chi Square Test*

Result: *(1) Nursing motivation which belongs to high category amounted to 40 nurses (65,6%) and that included enough category as many as 21 nurses (34,4%). (2) Compliance in the use of personal protective equipment of the majority who belonged to the duties category amounted to 46 nurses (75.4%) and sufficient category as many as 15 nurses (24.6%). (3) There is a relationship between motivation with the compliance of nurses in the use of personal protective equipment (APD) in Installation of Inpatient RSUD Pandan Arang Boyolali.*

Conclusion: *There is a relationship between motivation and nurse compliance in the use of personal protective equipment (PPE).*
